The law 34/2002, 11th of July, about services of the information society and Electronic commerce, has the obligation of all the services providers of the information society (holders of web pages) to inform in the correct way to all the users and visitors of the web about the Cookies installed on it.

In that way, the article 22.2 of the Law says:

“The providers of services could use devices of storage and recovery of data in terminal equipment of the recipients, only if they have given their permission after they have provided clear and complete information to them about their uses and in particular about the purposes of the data treatment. Everything in order with the Organic Law 15/1999, 13th of December, about the protection of the personal data.”
